RECRUITMENT NOTICE FOR THE POSTS OF PROFESSOR

Assam Skill University (ASU), Mangaldai is the first Skill University of Assam established under the Assam Skill University Act, 2020. The University is being set up by the Government of Assam with financial assistance through an externally aided project supported by Asian Development Bank. At present, the University is functioning from its Guwahati office, 3rd Floor-DECT Office Building, Employment Exchange Complex, AK Azad Road, Rehabari, Guwahati-781008.

Assam Skill University is in a mission to transform skill education ecosystem across North-Eastern Region (NER). It is envisioned to bring industry relevant skill courses, become a champion in technology adoption and create job opportunities for the youth in an equity and inclusive learning environment.

Applications are invited from eligible candidates of Indian nationality for appointment into regular positions of Professors who are keen to pursue a career in Assam Skill University (<https://asu.ac.in>) and intend to add value to shaping career of youths.

Additionally, retired University / College Professors / Assistant Professors, below the age of 62 years may also apply for contractual engagement (with last pay minus pension provisions). Persons already in service of any Government/Autonomous University/Institute/Organization may apply with provisions of joining on lien.

The candidates belonging to the category of differently abled will enclose necessary certificates with their application from a competent authority in support of their claim of disability. All such certificates should clearly mention the type of disabilities.

2. The Application fee to be paid through demand draft from any commercial bank in favour of Assam Skill University, Payable at Guwahati. Completed **Two copies** of application in prescribed form along with necessary enclosure must reach the office of **The Registrar, 3rd Floor, DECT Building, Employment Office Complex, Rehabari, Guwahati-781008 (Assam)** latest by **10.04.2024**.
3. The name of the post and school must be written on the envelope of the application.
4. Applicants has to submit API Score Sheet as per UGC Norms.
5. The authority may consider higher remuneration for deserving candidates.
6. Those in employment should submit their applications through proper channel or submit the NOC from the concerned authority along with the application. This is mandatory, failing which they will not be called for the test/ interview even if eligible.
7. All qualifications must be attained from recognized Board/Universities/Institutes. The Candidates who have obtained qualifications from any Board/University/Institution declared fake or not recognized by respective regulatory bodies shall not be eligible for consideration for any of the post advertised.
8. If a Grade Point System is adopted the CGPA will be converted into equivalent marks. Provide the relevant document of conversion of CGPA into equivalent marks along with application form.
9. The prescribed essential qualifications and experience indicated are bare minimum and mere possession of the same will not entitle any candidate to be called for written test/ teaching skill/ interview.
10. Only the shortlisted candidate will be called for recruitment test/ interview. Mere fulfillment of the eligibility will not entitle candidates to be shortlisted.
11. The vacancy shown in advertisement is indicative and may increase or decrease at the discretion of the University at the time of selection. The University reserves the right not to fill the post advertised without assigning any reason.
12. No TA/DA is payable for attending any test/ interview.
13. Application not supported with required application fee and self-attested copies of certificates/ testimonials will be rejected. Incomplete applications or the applications received without the prescribed fee or received after the last date of receipt of applications will be rejected and no correspondence will be entertained in this regard.
14. The period of experience wherever prescribed shall be counted only after obtaining the prescribed essential qualification. The experience certificate in support of the previous work wherever prescribed should clearly reveal about the period of work, designation with pay scale/ pay band with grade pay/ pay level. The certificate must be supported with salary slip/PF statement/ Form 16/ Bank Statement, or any other valid proof of salary paid as claimed in the certificate.
15. Concealment of facts or supply of wrong information will result in cancellation of candidature at any time in addition to legal action.

16. The Candidates are advised to keep on visiting the website of the University for related updates including any corrigendum/addendum, date of test/ interview/ list of shortlisted candidates etc. Further, no information in respect of this advertisement shall be published in the newspaper.
