The candidates belonging to the category of differently abled will enclose necessary certificates with their application from a competent authority in support of their claim of disability. All such certificates should clearly mention the type of disabilities.

- 2. The Application fee to be paid through demand draft from any commercial bank in favour of Assam Skill University, Payable at Guwahati. Completed **copies** of application in prescribed form along with necessary enclosure must reach the office of **The Registrar**, **3rd Floor**, **Dect Building**, **Employment Office Complex**, **Rehabari**, **Guwahati-781008** (**Assam**) latest by 09.09.2024
- 3. The name of the post and school must be written on the envelope of the application.
- 4. Applicants has to submit API Score Sheet as per UGC Norms.
- 5. The authority may consider higher remuneration for deserving candidates.
- 6. Those in employment should submit their applications through proper channel or submit the NOC from the concerned authority along with the application. This is mandatory, failing which they will not be called for the test/ interview even if eligible.
- 7. All qualifications must be attained from recognized Board/Universities/Institutes. The Candidates who have obtained qualifications from any Board/University/Institution declared fake or not recognized by respective regulatory bodies shall not be eligible for consideration for any of the post advertised.
- 8. If a Grade Point System is adopted the CGPA will be converted into equivalent marks. Provide the relevant document of conversion of CGPA into equivalent marks along with application form.
- 9. The prescribed essential qualifications and experience indicated are bare minimum and mere possession of the same will not entitle any candidate to be called for written test/ teaching skill/ interview.
