## **A. Project Background**

The National Policy for Skill Development and Entrepreneurship 2015 envisaged the establishment of skill universities in India. Skill universities are intended to offer industry-aligned skills education and training programs with multiple entry and exit options leading to National Skills Qualification Framework (NSQF) level 4 qualifications and above. They are integrated with higher education to create pathways for progression and mobility. They are also expected to conduct industry-relevant applied research and development (R&D), train the trainers and faculty of ITIs and polytechnics and promote quality and industry relevant training courses provided by various institutions as a hub. The concept of skill university anticipates the reform of the higher education system, laid out in the National Education Policy 2020, into a multidisciplinary and flexible system with multiple entry and exit points by integrating professional education and Technical and Vocational Education and Training (TVET). In September 2020, the Assam Legislative Assembly passed the Assam Skill University Act to establish Assam Skill University (ASU) in accordance with the regulations of the Government of India's University Grants Commission. The Government of Assam envisages ASU to (i) distinguish itself as a premium institution with its campus equipped with state-of-the-art facilities and technologies; (ii) conduct skills education and training integrated with higher education, applied R&D, entrepreneurship education and support; and (iii) raise skill levels to enhance the productivity and competitiveness of industries in Assam and the North Eastern Region. The state government also expects ASU to cater for the needs of students; TVET and higher education institutions; and industries in neighboring countries, which face similar challenges in skills education and training, and with which the state has long-standing relationships.

The ASU is proposed in Gerimari Chapori village under Mangaldoi Sub-division in Darrang district. It is located about 74 kilometers east of Guwahati, and falling within 25 kilometers of National Highway 27 connecting Guwahati with other major cities in Assam. National Highway 27 is integrated with other modes of transport (airways, waterways, and railways) and provides important connectivity to neighboring states and countries.

The Project is aligned with one of the strategic priorities of ADB's country partnership strategy for India (2018–2022), boosting economic competitiveness to create more and better jobs by addressing the skills gap to support industrialization. It will also support the following operational priorities of ADB's Strategy 2030: (i) addressing remaining poverty and reducing inequalities and accelerating progress in gender equality by improving access to skills education and training integrated with higher education to ensure pathways for progression and mobility, especially for female students; (ii) tackling climate change, building climate and disaster resilience, and enhancing environmental sustainability by adopting climate mitigation and adaptation measures; (iii) strengthening governance and institutional capacity by integrating digital technologies in-service delivery; and (iv) fostering regional cooperation and integration by supporting partnerships between ASU and institutions, and industries

in neighboring countries.

The Project is aligned with the following impacts: decent employment for all ensured and inclusive of sustainable infrastructure and industrial development accelerated. The Project will have the following outcome: industry-aligned and flexible skills education and training system strengthened in Assam. The Project will have five outputs.

**Output 1: University management and operating systems, business models, and faculty development and management systems developed.** For sustainable operation of ASU, the Project will support the development of ASU's (i) management and operating systems; (ii) leadership and management skills; (iii) student service systems and programs; (iv) business and financial models for skills education and training programs, applied R&D, and other services; (v) faculty recruitment, professional development, and performance appraisal and incentive systems; and (vi) digital campus platform, including systems for building and facility management; teaching and learning management; labor market intelligence; technology-enabled learning (e.g., simulation, augmented reality, and virtual reality); and online education. A framework of credits and pathways for skills education and training programs, including the recognition of prior learning, will be developed. Strategies to recruit, support, and retain female students, faculty, and staff, as well as those from disadvantaged groups, will also be prepared.

**Output 2: Environmentally sustainable and climate-resilient university campus and facilities developed.** The Project will support the design and construction of environmentally sustainable and climate-resilient ASU campus and facilities equipped with state-of-the-art technologies. ASU campus and facilities will comply with green building standards and adopt energy- and water-saving systems and climate adaptation measures. A sustainable campus and facility management strategy will be developed to reduce emissions and enhance energy efficiency. Features to address the needs of females and disadvantaged groups will be incorporated in the design of the ASU campus and facilities. The campus will open in 2024.

**Output 3: Industry-aligned and flexible skills education and training programs designed and delivered.** The Project will support, in collaboration with internationally and nationally renowned institutions and industries, the establishment of skills education and training programs at NSQF level 4 and above (certificate, diploma, advance diploma, bachelor of vocation degree, post-graduate diploma, master of vocation degree, and doctor of philosophy degree) at ASU for dropouts and graduates from senior secondary education, ITIs, polytechnics, engineering colleges, and universities, as well as professionals and working age population. These programs will integrate modules on environmental sustainability and climate change, and entrepreneurship. The delivery of skills education and training programs will start in 2023, ahead of the ASU campus opening, using online and off-campus modalities. The Project will also support the development of (i) career development programs and services, including those for female students and those from disadvantaged backgrounds; (ii) programs to develop soft skills such as communication and collaboration, and foreign language skills; and (iii) continuing education programs, including micro and alternative credential programs and customized programs for industry partners.

**Output 4: Capacity to manage and support entrepreneurship, applied research and development,**

**and technology transfer developed.** The Project will support the establishment of a faculty of entrepreneurship and innovation, which will (i) develop and manage networks of industry partners, alumni, business support, and funding organizations through an office of industry engagement and commercial ventures; (ii) provide support for the other faculties to deliver entrepreneurship education and support; (iii) manage incubator facilities and programs; (iv) manage joint and contract R&D, consultancy, and technology transfer for industry partners; and (v) provide support for the other faculties to develop, manage, and operate R&D facilities. A digital platform for entrepreneurship education and support, applied R&D Projects, and technology transfer will be developed. Feasibility studies for the establishment of industry-specific technology services, R&D, testing, and certification facilities in collaboration with industry and other institutions to promote digital and green transformation will also be supported.

**Output 5: Access to professional development and quality skills education and training resources improved.** Drawing on the systems, resources, and networks developed across different faculties at ASU, the Project will support ASU to establish itself as a hub for (i) professional development and quality skills education and training resources for trainers and faculty of ITIs and polytechnics, and (ii) partnerships with TVET and higher education institutions in neighboring countries (e.g., Bangladesh, Bhutan, and Nepal). The Project will support the establishment of a faculty of curriculum and faculty development, which will (i) conduct research on instruction, training, curricula, and assessment; (ii) support professional development of ASU's faculty and staff; (iii) deliver pre- and in-service training programs for trainers and faculty of ITIs and polytechnics; and (iv) disseminate state-of-the-art curricula, instructional and assessment strategies and approaches, and training materials. A digital platform to manage professional development of trainers and faculty of ITIs and polytechnics will be developed. Further, the Project will assist ASU in forming partnerships with TVET and higher education institutions in neighboring countries and developing skills education and training programs for common strategic industries, leveraging ASU's locational advantage at the center of various regional cooperation programs.

The Skill, Employment and Entrepreneurship Department (SEED) of the Government of Assam (GoA) will be the executing agency (EA) and Assam Skill University (ASU) will be the implementing agency (IA) of the Project. ASU has established a Project management unit (PMU) to carry out day-to-day Project management activities.

The government has requested a regular loan of \$112 million from ADB's ordinary capital resources to help finance the Project. The loan will have a 20-year term, including a grace period of 5 years; an annual interest rate determined in accordance with ADB's London interbank offered rate (LIBOR)-based lending facility; a commitment charge of 0.15% per year; and such other terms and conditions set forth in the draft loan and Project agreements. Based on the straight-line method, the average maturity is 12.75 years, and there is no maturity premium payable to ADB. ADB will finance the expenditures in relation to civil works, equipment and furniture, printing and materials, training and workshops, consulting services, Project management, and contingencies. The Government of Assam will finance operating costs of ASU, interest, and commitment charges. The loan agreement has been signed between ADB and Government of Assam on

17th December 2021 with the loan effectiveness date of 18th February 2022.

## **B. Social Safeguard Planning and Implementation Status**

All components under the proposed Project will be constructed within the proposed university campus and on encumbrance-free land owned by the Government except the City Campus constructed within the campus of ITI, Guwahati. The Project is category C for involuntary resettlement. No house will be acquired permanently or temporarily, from a private person/household, business establishment, or community. The Project has excluded the area where the involuntary resettlement envisaged.

However, recently, a total of 31 no. of Household (HH) residing adjoining the ASU main campus have voluntarily shifted to the nearby area due to challenges posed by the monsoon (refer to Annexure 1 for list of households). Their resettlement was voluntary and supported by the District Administration of Darrang.

The Project is category B for Indigenous Peoples. Assam is home to 3.88 million scheduled tribe people who accounted for 12.4% of the total population, according to the 2011 Census. The Project is not expected to cause any adverse impacts on the scheduled tribe population but benefit them. Youth and adults from scheduled tribe groups will have access to industry-aligned skills education and training, which would enhance their prospect of getting higher-paying, decent jobs. An Indigenous Peoples Plan (IPP) has been prepared with measures to improve access to skills education and training, and career development programs and services for the scheduled tribe population and disclosed on ADB website.

The ASU through its PMU will coordinate the implementation and monitoring of the IPP with ASU, the SEED, and other government departments. A full-time gender and Indigenous People's specialist mobilized to the PMU to (i) facilitate the implementation of IPP; (ii) apply the Project GRM together with the PMU environment specialist; (iii) organize training on IPP; and (iv) prepare and submit semiannual social safeguards monitoring reports. The PMU gender and Indigenous People's specialist is supported by the social development specialist from the consulting firm for Project management support. Additionally, the consulting firm for student outreach support will assist ASU in implementing the IPP.

## **C. Objective of the Due Diligence**

The social safeguard due diligence study is carried out by the Project team during the Project implementation stage due to the voluntary shifting of 31 households who were residing within the Assam Skill University campus. These households have approached the District Commissioner to voluntarily shift from the present state to the adjacent land of the University, due to challenges faced during monsoon season keeping in view of the near future. The land transfer process has been done by the District Administration, although the legal allotment process is under process. Hereby, a social safeguard due diligence study has been conducted to assess the IR and IP impacts due to the

voluntary shifting of the families, to assess and confirm that there will be no land acquisition or any involuntary resettlement (IR) or livelihood impacts—temporary or permanent—on any titled or non-titled persons. All works were carried out within the allotted government land and result in no resettlement impacts or cause any impact on Indigenous People.

#### **D. Need for the Due Diligence**

The social safeguard due diligence study is conducted in the Q1 of 2025, to confirm that 31 households (which were residing within the campus of Assam Skill University) have voluntarily relocated to the adjacent area of Assam Skill University due to the seasonal water logging in their previous residences during the monsoon. The District Commissioner (DC) of Darrang had received requests from 34 individuals requesting voluntary shifting of their houses and upon prior survey and assessment (conducted by Circle Office), the District Authority had made necessary arrangements and shifted the families to the land earlier allocated for the ASU.

Of the 34 applications received by the district administration and the 31 households surveyed by the Circle Office, field verification conducted by the project team confirmed the presence of 31 relocated households (**refer to Annexure 1**). These households have been moved to adjacent land previously allocated for Assam Skill University (ASU). However, field verification by the project team has identified key details, presented in the comparative analysis below –

##### **Applications vs. Verified Households**

1. A total of 34 applications were submitted to the District Commissioner (DC), Darrang (**refer to Annexure 2**).
2. Earlier field verification by the Circle Office confirmed 31 households but the final number of households from the list were 28 because one household named Ramlal Chouhan was repeated and two households named Rashmi Ram Nath and Arabindra Deka had migrated to another district (refer to the old survey list in **Annexure 3**).
3. Recent field verification survey conducted by the project team after the shifting of the

households, confirmed 31 households out of the total applications of 34 (refer to the comparison sheet in **Annexure 4** including photographs in **Annexure 4a**).

4. Two households (Rashmi Ram Nath and Arabindra Deka) were pensioners and had migrated to another district (refer to Panchnama in **Annexure 5**).
5. Three applications (Shri Dina Chouhan, Shri Janata Chouhan and Shri Nirmal Chouhan) were not found in the Circle Office list, but field surveys confirmed that plots had been allocated to Shri Dina Chouhan and Shri Janata Chouhan. Whereas Shri Nirmal Chouhan was allotted the plot in the name of his mother, Kaluwa Devi, instead of his own name (since he and his mother both had given applications).
6. One applicant named Kalu Chouhan had submitted application to DC but he was allotted a plot/house in the name of his son Dina Chouhan.
7. One applicant (Pradip Chouhan) was allotted a plot/house in the name of his father, Antowa Chouhan, instead of his own name (since he and his father both had given applications). Additionally, he was found to be residing in a room built on the plot allotted to his father.
8. Lt. Raju Choudhury's plot/house was allotted to his wife, Sabita Choudhury, ensuring household security for women. Also, Sabita Choudhury was a applicant (her application was found in DC office list).
9. Ajay Chouhan had given application to DC in the name of his mother (Fulmati Devi) and wife (Lalita Chouhan), for which the plot/house was allotted to Fulmati Chouhan, being the elder member of the family.
10. Three applicants (Shri Mithun Chouhan, Rajkumar Chouhan and Ajay Chouhan) formal applications to DC were not found but their names were found in the list surveyed by the circle office. They were verified and confirmed to receive a plot/house. Also, in the circle office list, the name of the guardian of Ajay Chouhan was mistaken as Nagina Chouhan, it should have been Nirgun Chouhan, confirmed by the applicant.

#### 11. Verification of Documents

- Guardian name corrections were made based on Aadhaar verification, ensuring accuracy in records.
- Title & name corrections were confirmed through Aadhaar verification, such as:
  - Hareram Deka's title was confirmed as Choudhury, not Deka
  - Fulmati Devi's Aadhaar verification confirmed both "Devi" and "Chouhan" as correct titles.
  - Ajay Chouhan's guardian name was confirmed to be Nirgun Chouhan, instead of Nagina Chouhan.

Further, the district administration prioritized infrastructure development over direct compensation, ensuring sustainable living conditions for the relocated families by providing land filling to prevent submergence, electricity connections, road connectivity, individual tubewells, and sanitation facilities



(toilet rings), etc. to ensure proper utilization of resources.

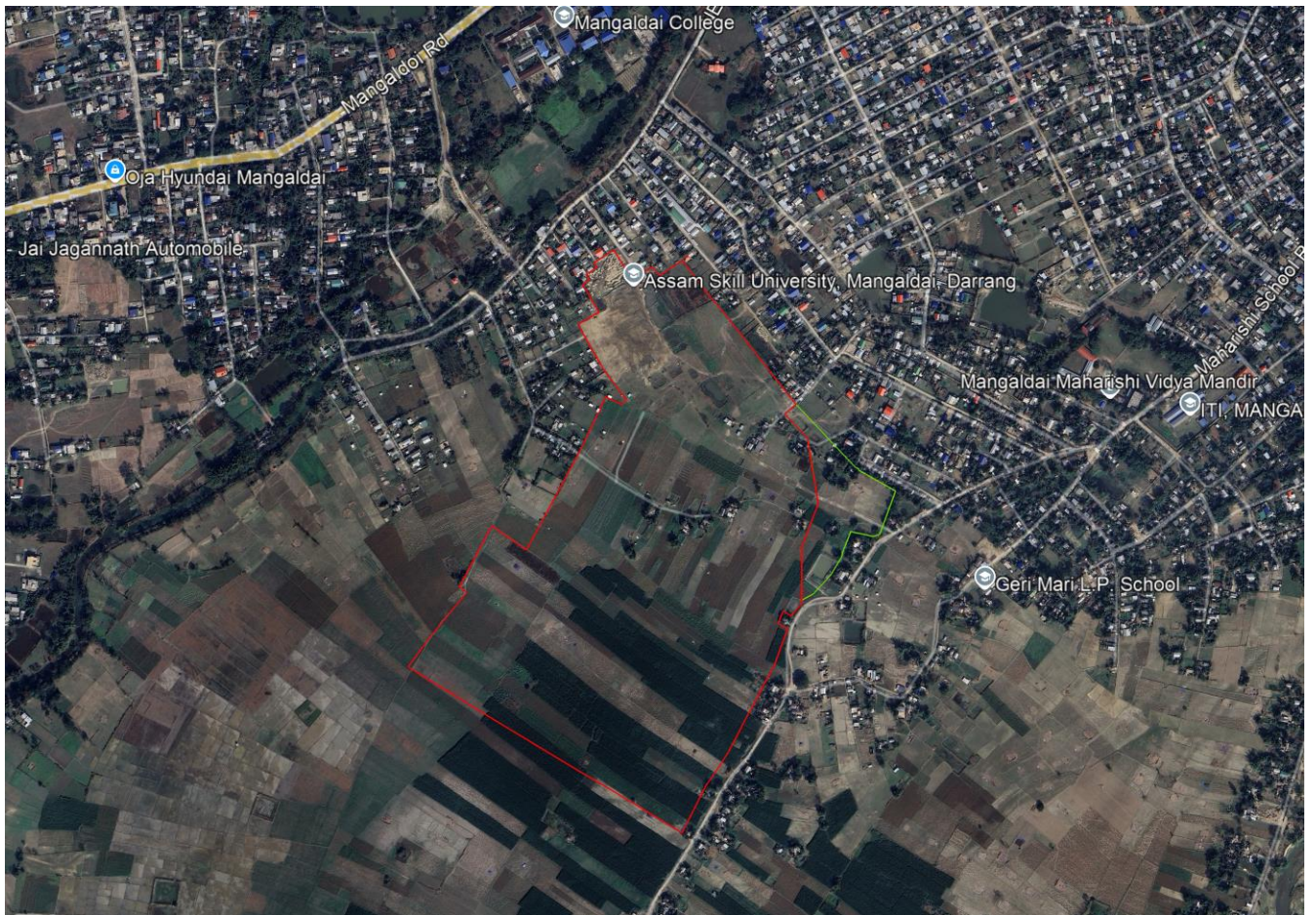




Figure 2: Old Layout Map of Proposed ASU

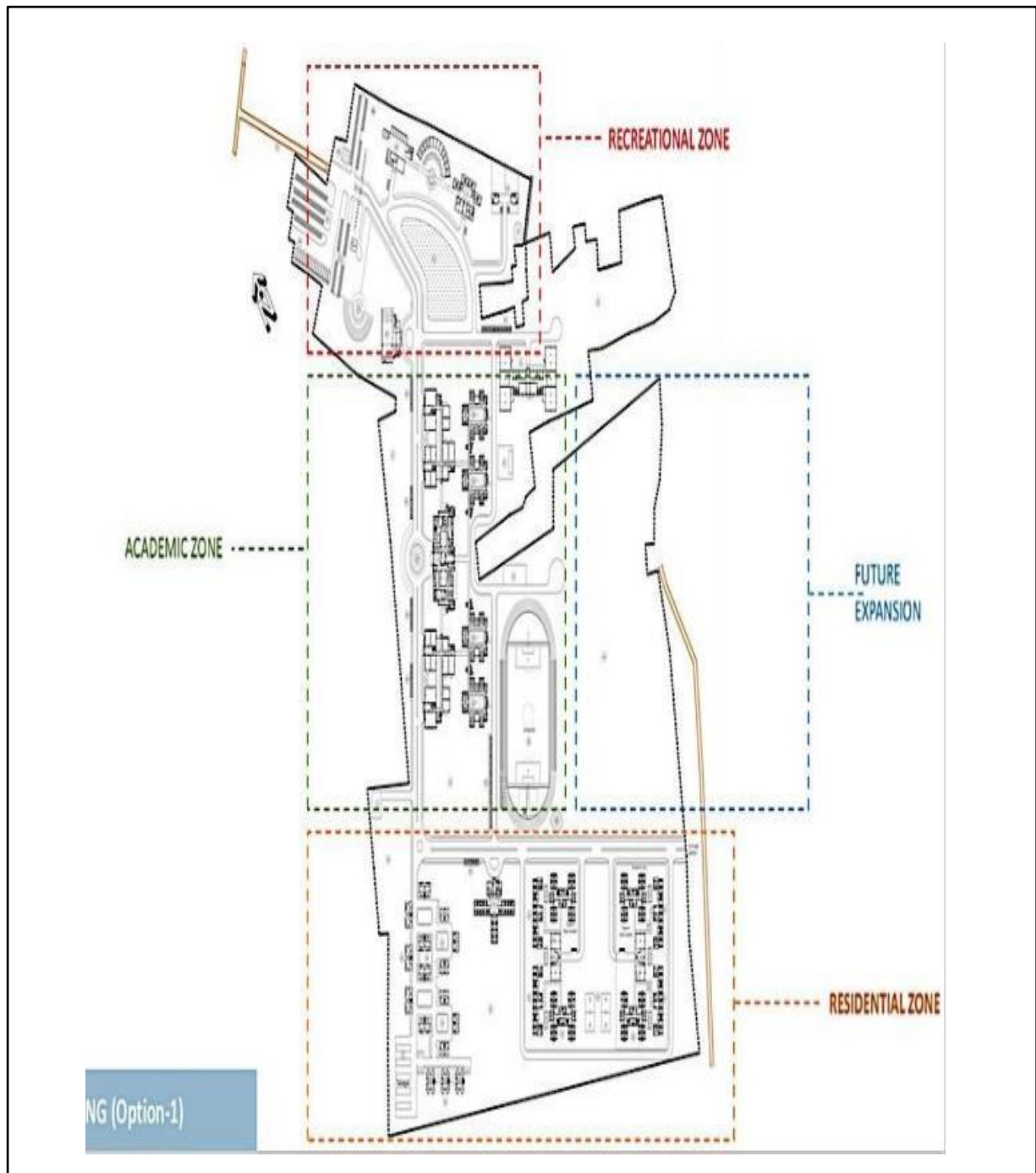
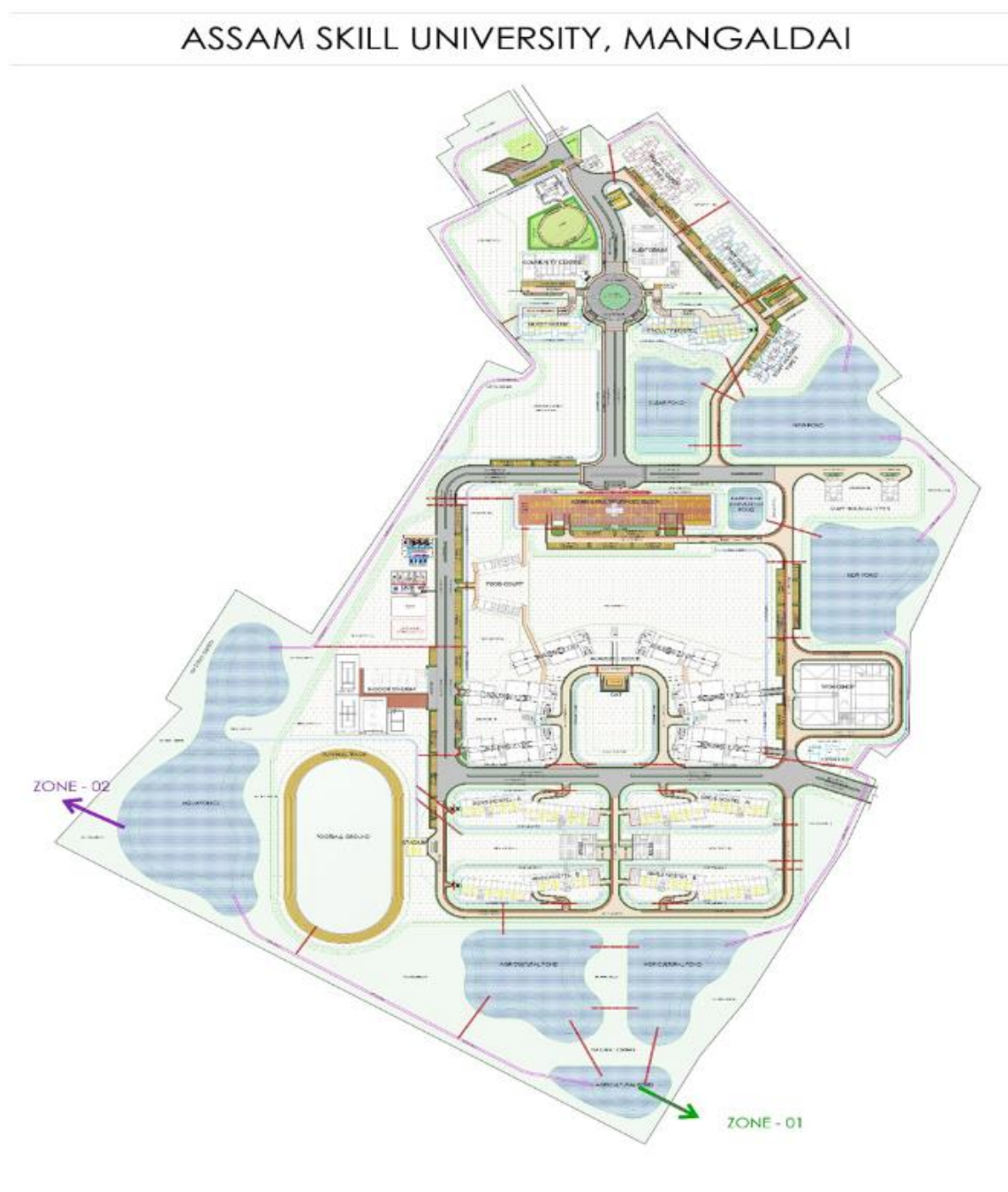


Figure 3: New Layout Map of Proposed ASU



### E. Detailed Design and Construction of ASU

For ease of implementation, ASU campus development has been divided into two phases, namely, Phase 1 and Phase 2. The phase 1 buildings along with the plinth area and stilt area are as follows:

- i. Admin and multipurpose buildings, 12747m<sup>2</sup>
- ii. Academic buildings and laboratories, 25978 m<sup>2</sup>
- iii. Workshops and store, 3457 m<sup>2</sup>
- iv. Faculty hostel, 12747m<sup>2</sup>
- v. Guest house, 1825 m<sup>2</sup>

- vi. Hostel (A&B), 19733 m<sup>2</sup>

Similarly, the phase 2 buildings along with the plinth area and stilt area are as follows:

- i. Staff Quarters (Type 2, 3,4,5), 15653 m<sup>2</sup>
- ii. Mess and canteen, 1200 m<sup>2</sup>
- iii. Community center, 1600 m<sup>2</sup>
- iv. Food Court, 800 m<sup>2</sup>
- v. Sub- station pump room pol store, 319 m<sup>2</sup>
- vi. Security office, 264 m<sup>2</sup>
- vii. Stadium block, 513 m<sup>2</sup>
- viii. RC roof corridor, 1200 m<sup>2</sup>
- ix. Garage with metal roof corridor, 3102 m<sup>2</sup>
- x. Open air theatre, 250 m<sup>2</sup>
- xi. Place of worship, 100 m<sup>2</sup>

The detailed design and construction of ASU campus and facilities will mainly be for buildings, workshops and laboratories and furnishing these with equipment, instruments, and machinery. In addition to electrifying these buildings, other facilities include internal roads, storm water drainage, water supply and sewage network systems and sewage treatment plant, rain water harvesting and building management system with green building campus, barrier free design will be installed as part of utility infrastructure in the proposed built-up area is 80,129 m<sup>2</sup>.

The

preliminary design of ASU campus and facilities has been finalized after topographic survey and with due consideration to other climatic and location specific factors such as intense rainfall and earthquake zone V co-efficient. To make campus ambience soothing to the eyes, plantation of shrubs and trees, landscaping in open areas and development of existing small ponds as water bodies shall also comprise the main campus.

## **F. Methodology for Due Diligence Study**

The social safeguard due diligence study was conducted through a multi-step verification process to ensure accuracy in household relocation and allotment of structures. The study was based on the verification of applications received from the District Administration, cross-checking with the list shared by the Circle Office, and confirming the exact number of households shifted.

To ensure a comprehensive assessment, the following methodologies were employed:

1. **Field Verification** – A systematic door-to-door visit was conducted to validate the presence of households, assess their relocation status, and document their living conditions.
2. **Community Consultations** – Discussions were held with the families to understand the support provided by the District Commissioner (DC), including infrastructure improvements

such as land filling, electricity, sanitation, and road connectivity.

3. **Institutional Consultations** – Meetings were conducted with the Circle Office and DC to verify the status of legal allotment and ensure compliance with administrative procedures.
4. **No Objection Certificates (NOC) Collection** – Households were asked to provide NOCs, confirming their acceptance of the relocation and the facilities provided.
5. **Third-Party Validation** – Independent verification was carried out through Gaon Burha (village head) to ensure transparency and validate the findings.

This multi-layered approach ensured that the due diligence study was rigorous, transparent, and aligned with social safeguard principles, providing a clear assessment of household relocation and support mechanisms.

### **G. Findings of Due Diligence Study**

The social safeguard due diligence study conducted in Q1 of 2025, confirmed that 31 households (residing within the campus of Assam Skill University) voluntarily relocated from the Assam Skill University (ASU) campus to adjacent land due to seasonal submergence during monsoons. This relocation was facilitated by the District Commissioner (DC) of Darrang, while the relocation process included significant infrastructure improvements such as land filling, electricity connections, road access, and sanitation facilities to ensure sustainable living conditions. Field verification, community consultations, and institutional reviews confirmed that the Project intervention will not cause any IR impacts as no land acquisition or any involuntary resettlement (IR) or livelihood impacts—temporary or permanent—on any titled or non-titled persons by the Project. All works were carried out within the available government-allotted land. In relation to the voluntary relocation of families and the resultant vacant area at the Assam Skill University main campus, no work has commenced on the mentioned area as of the date of this communication and no work will commence prior to ADB's clearance.

Additionally, government records and the distribution of land titles to relocated families will be completed in due course, ensuring legal ownership and stability. In the mean-time, the Circle Officer has sent a letter to the District Commissioner (DC) after receiving the final list of surveyed households from the project team (post relocation of households). The summary of the letter along with the updated list of the households is shared in **Annexure 6**. Further the list is forwarded to DC, Darrang to ensure necessary actions. Also, to enhance accessibility, planning for infrastructure improvements for a well-connected drainage system and a developed road network is underway. While temporary drainage is dug by the project team to ensure storm water management of the shifted area. In terms of livelihood opportunities, relocated households have established eateries, set up temporary shops, and engaged in animal husbandry. These initiatives have created stable income sources and reduced economic vulnerability. To address sanitation needs, individual households have been provided with pit latrines, promoting hygiene and proper waste management. Additionally, handpumps have been installed to

improve access to clean water, ensuring better living conditions for the community.

Based on the assessment, the Project has been categorized as Category-C with regard to the Involuntary Resettlement (IR) requirement of ADB SPS 2009. The proposed sub-project implementation will not trigger any IR or Indigenous Peoples (IP) impacts, and the Project categorization remains unchanged as Category “C” for Involuntary Resettlement (IR) and Category “B” for Indigenous Peoples (IP).

### H. Stakeholders Consultation under the Project

Stakeholder consultation is an essential tool for conducting a social safeguard due diligence study. Various stakeholders, including the Project team—comprising the Gender and Indigenous Peoples Specialist and the Social Safeguard Expert (CS 01)—along with HSE managers from contractors, public representatives such as the village head and sarpanch, community leaders, and members of the community residing near the proposed site, were consulted. Their feedback has been duly incorporated into the report.

During the consultation, it was identified that 31 households had voluntarily relocated due to challenges posed by the monsoon, which had affected their lives and livelihoods. Their resettlement was entirely voluntary and was facilitated with the support of the District Administration of Darrang. In recognition of this, the following benefits were provided to them:

- a. **Transportation of Materials** – Assistance was given to transport materials to the new area.
- b. **Land Filling** – The resettlement area underwent landfilling to ensure stability and usability.
- c. **Water Supply** – Individual handpumps were installed to provide a reliable water source.

- d. **Sanitation Facilities** – Toilet rings were provided to each household for constructing toilets.
- e. **Electricity Connection** – Electricity connections were established to ensure access to power.



Furthermore, during the consultation, all 31 households provided a **No Objection Certificate (NOC)**<sup>1</sup> to the university, affirming that their relocation was purely voluntary and did not result in any adverse impact on their lives or livelihoods. The decision to relocate was collectively taken by the affected households after considering the prospects of the new settlement area. Additionally, these NOCs have been **validated through third-party verification** by the village head (**Gaon Pradhan**) of Gerimari village, further reinforcing the voluntary nature of the resettlement process. The attendance sheet of the consultation is attached in **Annexure 7**. Additionally, a public consultation was conducted on 26.03.2025 with the voluntary displaced people and the record of observations is attached in **Annexure 7a**. The no-objection certificate and third-party validation certificate for all 31 households have been attached in **Annexure 8**.

The resettled families have expressed that these measures have significantly improved their living conditions and overall well-being.

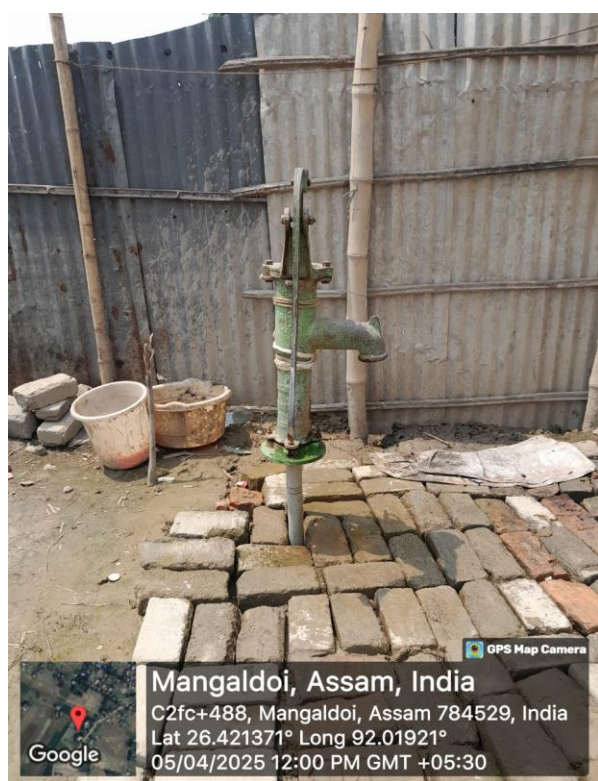

## **I. Grievance Redressal Mechanism**

The affected person(s)/aggrieved party can give their grievance verbally or in written to the ASU site office in Mangaldai. Grievances of affected person will first be brought to the attention of the immediate officer GRO 1 – PTM, ASUP, in charge of the GRM (site level), who can resolve the issue at the site level office with the help of representative of contractor will also be responsible in resolving the specific site level issues. If the matter is not resolved within 7 working days period by the site in-charge, it will be brought to the notice of GRC constituted for the purpose at PMU. This GRC at the PMU level is headed by the GRO 2 - CEO, ASUP and Registrar, ASU, who shall discuss the issue in its meeting and resolve the issues within 15 working days from the day of receiving the grievance by PMU. If the matter is not resolved by GRC at the PMU level within the stipulated time, it shall be referred to GRC at State Level Project Steering Committee by the officer in-charge of the site (GRO 1 - PTM, ASUP) which will resolve the issue within one month of receiving of the complaint at Steering Committee.

However, the aggrieved person/party can bring the matter to the Court of Law at any point of time. The PMU and ASU site office shall keep records of all grievances received including contact details of the complainant, date of receiving the complaint, nature of grievance, agreed corrective actions

and the date the actions were taken and their final outcome. A complaint register will be maintained at construction site. The cost for the operation of GRM will be accounted for in Project cost as part of PMU operation.

### **Composition of GRC**

#### **Site Level Grievance Redress Committee (GRC-Site)**

This committee is comprising of Project Technical Manager (PMU, ASUP), Site Engineer (PMU, ASUP), PMU Environment Specialist, PMU Gender and Indigenous Peoples Specialist, DPM, ASDM - Darrang, and one locally elected representative from Panchayat. The GRC-Site will be headed by Project Technical Manager (PMU, ASUP).

**GRC at PMU level:** GRC at PMU includes the CEO, ASUP & Registrar, ASU, DPD, ASUP, HR & Admin Executive (PMU, ASUP), PMU Gender and Indigenous People Specialist, PMU Environment Specialist, Communication Manager (PMU, ASUP) and Legal Advisor, ASDM. The Committee is headed by the CEO, ASUP & Registrar, ASU. This committee shall look into the matters, which are referred to and not resolved by GRC at site level. If the matter is not resolved by the GRC at PMU level within 15 working days, then the aggrieved person or party can bring the matter to the state level Project steering committee (PSC) which is in-charge of the Project. Affected person or aggrieved party can approach the GRC for redress of his/her grievance through any of the following modes:

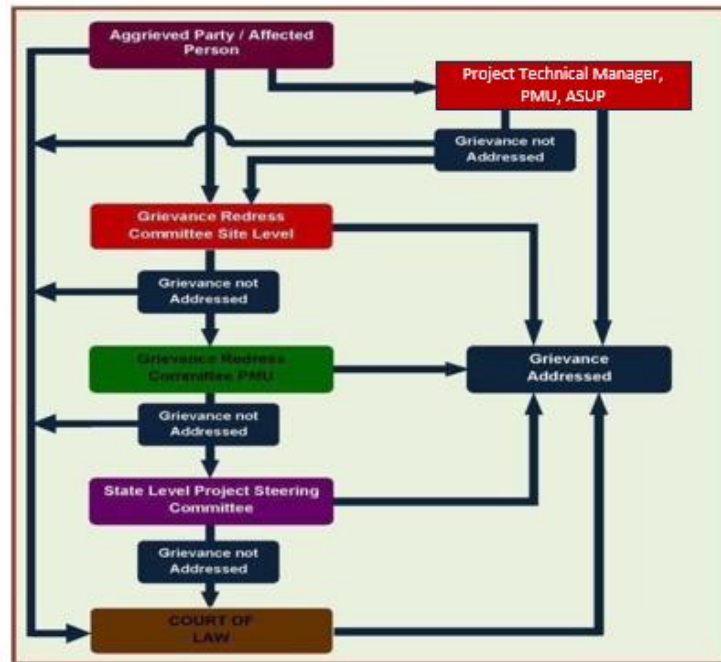
**Web based:** A separate corner has been developed at the ASU website, so that public and affected person can register their complaints in the online column during execution stage.

**Project Information board:** ASU Project information board has been installed at the ASU Project site. Contact details (name, phone number and email) of GRO is available in the board.

**Telephone or e-mail based:** A telephone number is available on the website of ASU so that general public can register their complaint through telephone/mobile phone. An e-mail id has been created and is available in the ASU website so that a complainant can register a complainant through e-mail as well.

- One complaint register is also being maintained at the construction site by the contractor where people can register their complaint. In addition to it grievance register format is also available at site and at PMU for people to register their grievances in the prescribed format and put it in the drop-box.
- The official copy of approval letter of Grievance Redressal Mechanism (GRM) was shared as annexure with the SSMR of the reporting period of February 2022 to July 2022. The grievance redress mechanism for the Project is shown in Figure 5. The earlier GRC is dissolved due to drop out of some members and the new GRC is formed in the month of September, 2024.

## J. Institutional Arrangements

The Government of Assam through Skill, Employment, and Entrepreneurship Department (SEED) is the executing agency (EA). The EA (i) assumes overall responsibility for the execution of the Project and reporting; (ii) engages adequate permanent or fixed-term staff to implement the Project; (iii) provides overall strategic guidance on technical supervision and Project execution; and (iv) ensures overall compliance with the loan covenants.

The implementing agency (IA) for the Project is ASU. The IA responsibilities include (i) Project planning and budgeting; (ii) day-to-day assistance, supervision and guidance for the Project site team and consultant; (iii) review ASU components for due diligence requirements and approve sub Project proposals; (iv) bidding, evaluation and contract award; (v) managing and disbursing funds; (vi) review compliance with loan covenants, contract specifications, work plans and quality control; (viii) monitoring and reporting of social safeguards; and (viii) consolidate and submit progress reports,

finance and accounting/audit reports, and matters requiring higher level decision to Project steering committee (PSC) and ADB.

A state level PSC has been established for the proposed Project. This committee is chaired by Secretary SEED, with secretaries of industry, agriculture, land and revenue, information technology, health, planning and finance, handloom and textile, tourism, transformation and development, education, public works, social justice and empowerment, and the vice chancellor of ASU as members. The PSC has been empowered to take all decisions on behalf of the state and will provide overall advice and guidance to the EA, IA, and PMU.

ASU has established a PMU, headed by a full-time Project Director (PD) / Chief Executive Officer (CEO), ASUP cum Registrar at ASU. The PMU also have safeguards specialists (social and environment). The PMU will be the nodal agency for overall management of all Project activities and will be responsible for overall Project planning and implementation with day-to-day supervision and guidance for the site team, contractors and consultants.

The construction of ASU campus will be supervised by the Construction Supervision and Quality Assurance (CSQA) firm. The CSQA firm will be responsible for: (i) providing day-to-day assistance, supervision and guidance to the contractor; (iii) reporting to PMU; (iv) supervising construction, conducting quality control, advising PMU on approval of progress payments to contractors; and (v) maintaining records and accounts on an up-to-date basis and making these available to ADB, its missions, or auditors for inspection.

The Project management consultant (PMC) will be engaged to provide support to the PMU in overall planning, risk management, implementation, monitoring, reporting, and evaluation under the Project. The PMC team will have experienced professionals specializing in areas such as procurement, social safeguards, environmental safeguard, finance, etc. The PMC will assist the PMU and ASU in meeting the relevant requirements of ADB, GoA, and GoI for Project implementation. The PMC team will report and work under the overall guidance of the PMU. In order to ensure effective implementation of safeguard related components in the Project, PMU will have safeguard experts (one environmental specialist and one social development specialist). These safeguard experts will ensure implementation of environmental management plan and social safeguard actions under the Project.

## **K. Conclusion and Recommendation**

Based on the current due diligence study carried out for establishment of ASU with additional land allotment and voluntary shifting of 31 households, it is concluded that the Project intervention will not cause any IR impacts as no land acquisition or any involuntary resettlement (IR) or livelihood impacts—temporary or permanent—on any titled or non-titled persons by the Project. All works were carried out within the available government-allotted land. In relation to the voluntary relocation of

families and the resultant vacant area at the Assam Skill University main campus, no work has commenced on the mentioned area as of the date of this communication and no work will commence prior to ADB's clearance. Further, it is confirmed that the establishment of ASU will not pose any impact to Indigenous People.

Based on the current social safeguard due diligence assessment following recommendations are made, which will be complied with by the ASUP during the Project implementation.

- The land that has been voluntarily vacated due to water logging during rainy season, has not yet been used for construction activities, and no impacts have occurred thus far.
- During the Project implementation, ASU will ensure that the Project does not involve any involuntary resettlement impacts or impact on Indigenous Peoples.
- In the event that the Project does have any such impact, ASUP will report to ADB and mitigate the impacts as per the requirement of SPS.
- Continuous follow up will be made with the community people to ensure to provide legal documentation to the voluntarily displaced persons
- Ensure to monitor the development, such as (drain, road, electricity supplies, etc.) in the voluntarily settled area.
- The Project will ensure proper drainage system in the area and will not cause any additional water lodging in the area.
- Awareness program for the GRM will be conducted at site information regarding GRM and civil work schedule will be disclosed by the contractor at Project site.
- The Project will ensure engagement of all stakeholders and continuous consultation process throughout the implementation period.
- ASUP will ensure periodic reporting of the above to ADB by submitting semi-annual social monitoring report including progress of agreed measures and compliance of loan covenants.

**Summary of the letter to DC, Darrang by Circle Officer, Mangaldai Revenue Circle**

Based on the field investigation conducted in accordance with letter M.R.C-4/2021/318 dated 10/01/2024, a list of 31 families was submitted. Among them, two individuals—Arabindra Deka (son of Shishuram Deka) and Rashmi Ram Nath (son of Chila Ram Nath)—were identified as government pensioners. During Assam Skill University's survey, 31 families were observed residing in the area; however, discrepancies were noted in the previously submitted list. Specifically, the name of Ramlal Chauhan (son of Kalu Chauhan) was mistakenly included twice, while Dina Chauhan should have been listed at serial number 26, as he was found in the area. Additionally, individuals at serial numbers 11, 16, and 17 in Assam Skill University's recent survey list were not found during the earlier survey. Therefore, these corrections should be considered for ensuring accuracy in the final household resettlement records. List attached here -
