Terms and Conditions

1. **Time of Reporting:** No candidate shall be permitted to enter the examination/interview venue after the above-mentioned reporting time.
2. **Venue of Interview:** Guest House, Assam Skill University Campus, Mangaldai.
3. **Remuneration:**
 - Appointed Guest Faculty shall be paid ₹1,500/- per lecture, subject to a maximum of ₹40,000/- per month. Guest Faculties, who are already employed in government institution shall be paid ₹800/- per lecture, subject to a maximum of ₹40,000/- per month. No other allowances shall be admissible.
 - Appointed Guest Instructor shall be paid ₹800/- per lecture, subject to a maximum of ₹25,000/- per month. Guest Instructors, who are already employed in government institution shall be paid ₹400/- per lecture, subject to a maximum of ₹25,000/- per month. No other allowances shall be admissible.
4. **NOC:** Candidates presently employed must submit a No Objection Certificate (NOC) from their employer.
5. **Application & Documents:** Candidates must fill up the prescribed application form (attached) and bring all original documents, along with one set of self-attested photocopies, at the time of interview.
6. The positions shall neither be regularized under Assam Skill University (ASU) nor absorbed under any job/programme of ASU in future. Further, no person so engaged shall have any right to claim permanent absorption in any post of ASU
7. All qualifications must be obtained from recognized Boards/Universities/Institutions. Candidates possessing qualifications from institutions declared fake or unrecognized by the concerned regulatory bodies shall not be eligible.
8. The vacancies indicated are purely indicative. The University reserves the right to increase/decrease/modify the number and nature of posts or to cancel/withdraw/reschedule the recruitment process without assigning any reason.
9. The decision of the Competent Authority in all matters relating to eligibility, selection, and conduct of the interview shall be final and binding, and no correspondence shall be entertained.
10. No TA/DA shall be admissible for attending the interview.
11. Candidates must be in sound health and shall be required to undergo medical examination, if selected, as per university norms.
