- (a) Your price bid shall be for all the items as described in attached documents and submitted only in the attached **Form of Bid** with the priced **Supply, Delivery and Price Schedule**. The currency of quoted prices and payment shall be **Indian Rupees (INR)**.
- (b) The prices should be quoted for supply and delivery to O/o Assam Skill University, Interim Campus, ITI Complex, Birubari -781001 and should be accompanied by adequate technical documentation and catalogue(s) and other printed material or pertinent information (in English language) for each item quoted, including names and addresses of firms providing after-sales service facilities in **Interim Campus, Assam Skill University, ITI Complex, Birubari - 781001**.

- (c) Your bid must be signed by you or your authorized representative. Without a signature in your **Form of Bid**, your bid will not be considered further.
- (d) Your bid should be valid for a period of **60** days from the deadline for submission of the bids as indicated below. If you withdraw your bid during the validity period and/or refuse to accept the award Purchase Order when and if awarded, then you will be excluded from the list of Suppliers for three years.

#### **5. Evaluation and Comparison**

- (a) Bids determined to be substantially responsive will be evaluated by comparison of their offer prices. A bid is not substantially responsive if it contains material deviations or reservations to the terms, conditions, and specifications in this **Bid Document**.
- (b) In evaluating the bids, the Purchaser will adjust for any arithmetical errors as follows:
  - I. where there is a discrepancy between amounts in figures and in words, the amount in words will govern; and
  - II. where there is a discrepancy between the unit rate and the line-item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern.

If you refuse to accept the correction, your bid will be rejected.

#### **6. Award of Contract**

- (a) The Purchaser shall award the Purchase Order to the Supplier whose bid has been determined to be substantially responsive and who has offered the lowest price bid. Accordingly, award will be given to only one supplier.
- (b) The Supplier whose bid has been accepted will be notified by the Purchaser within **60 days** (Sixty Days) from the date of submission of bids through the return of a copy of the **Form of Bid** signed by the authorized representative of the Purchaser.
- (c) The successful Supplier will be issued a **Purchase Order** along with the **Terms and Conditions** of the Bid Document.

### **1. Applicable Law**

- 1.1 The Contract shall be interpreted in accordance with the laws of the Purchaser's country.

### **2. Language**

- 2.1 All communications and documents related to the Contract shall be in English.

### **3. Fixed Contract Price**

- 3.1 The prices indicated in the Form of Bid are firm and fixed and not subject to any adjustment during contract performance.

### **4. Delivery Schedule**

- 4.1 The delivery should be completed as per schedule indicated in the **Supply and Delivery Schedule** but not exceeding 30 (Thirty) days from the date of receipt of Purchase Order.

### **5. Required Technical Specifications (with attachments as necessary)**

- (a) General Description
- (b) Specific details and standards

Supplier confirms compliance with above specifications.

### **6. Delivery and Documents**

- 6.1 Upon delivery and Installation, the Supplier shall provide the following documents to the Purchaser:

- (a) copies of the Supplier's invoice showing goods' description, quantity, unit price, and total amount;

If goods are coming by courier, supplier shall also provide prior to delivery, copies of documents that will enable Purchaser to receive the goods. The above documents shall be received by the Purchaser at least one week before arrival of the goods and, if not received, the Supplier shall be responsible for any consequent expenses.

### **7. Taxes and Duties**

- 7.1 The Supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted Goods to the Purchaser.

### **8. Payment**

- 8.1 Payment of the contract price shall be made in the following manner:

- (a) 100% within 60 days from receipt by the Purchaser of the delivered goods on site, installation and after satisfactory acceptance in accordance with the contract (or whatever is appropriate for the goods being procured) including the required documents.
