2. The Quotation shall comprise the following:

- Duly filled Form of Quotation
- Bid security amounting to INR 45,000/- (Rupees Forty Five Thousand) only to be paid through online payment mode in the e-procurement portal (assamtenders.gov.in). No exemption on Bid Security

- c) Technical Specifications: confirmation that the offered books and Related Services conform to the required specifications.

3. If you/your firm, however, falls under any of the following conditions, your proposal shall not be considered:
- (a) you/your firm are/is not a citizen/national of an ADB member country, or
 - (b) you/your firm have/has been associated with the firm that prepared the design and specifications, or engaged in the preparation of the Project for which the contract that is subject of this request for quotations was identified, or
 - (c) you/your firm are/is owned by the Purchaser, or
 - (d) you/your firm are/is currently sanctioned or temporarily suspended by the Asian Development Bank for a violation of its [Anticorruption Policy](#) (1998, as amended to date), or
 - (e) the importation of goods or services from your country or any payment to persons or entities in your country is prohibited in compliance with a decision of the United Nations Security Council under Chapter VII of the Charter of the United Nations.
4. **Qualification of the Bidder:**
- a. To be qualified, you must have experience as an authorized supplier of the equipment covered by this **Request for Quotation** and, as evidence, you must also attach a document of your experience as supplier in at **least one contracts** in the last 3 years of **Contract amount not less than INR 35 Lakh (Rupees Thirty Five Lakh) or two contract not less than 26 Lakh (Rupees Twenty Six Lakh) each or three contract not less than 18 Lakh (Rupees Eighteen Lakh) each similar to the items in the supply schedule of this contract.**
 - b. The bidder should have average annual financial Turnover during the last three years of **Rs. 66 Lakh (Rupees Sixty Six Lakh)** (Please submit audited turnover certificate for the last three years **2021-22, 2022-23, 2023-24** with valid UDIN)
 - c. The bidder should ensure the offers are strictly as per specification in the RFQ. Merely copying the specification in the quotation shall not make the firms eligible for consideration. A quotation has to be supported with the printed technical catalog/brochure and the specification mentioned in the quotation must be reflected/supported by such technical catalog/brochure.
 - d. Price Quotation should contain the price for all items. If the price quotation is missing any item, then the quotation will be rejected.

5. Your quotation should be submitted in accordance with the following instructions, procedures, and the terms and conditions of the **Contract**.

Preparation of Quotations

- (a) Your price quotation/(s) shall be for all the items as described in attached documents and submitted only in the attached **Form of Quotation** with the priced **Supply, Delivery, Installation and Price Schedule**. The currency of quoted prices and payment shall be **Indian Rupees (INR)**.
- (b) **The price quoted for each item should be inclusive of 3-year onsite warranty.**
- (c) **The bidder shall also consider the cost of Training while quoting the rates of the equipment as specified below.**
- (a) **Installation and commissioning of goods shall be covered under supplier's scope and supplier shall consider this cost in quoting the rates.**
- (b) **Related Works and Services - any minor electrification, Earthing, Piping (water, pneumatic air etc) and Civil work (if required) to be performed by the supplier, at the time of installation and commissioning of the supplied equipment at their own costs. However, such costs involved to be included in the price bid**
- (c) The prices should be quoted for supply and delivery to **ASU Interim Campus, ITI Guwahati Campus, Birubari** and should be accompanied by adequate technical documentation and catalogue(s) and other printed material or pertinent information (in English language) for each item quoted.
- (d) Your quotation must be signed by you or your authorized representative. Without a signature in your **Form of Quotation**, your quotation will not be considered further.
- (e) Your quotation(s) should be valid for a period of **60** days from the deadline for submission of the quotation/(s) as indicated below. If you withdraw your quotation during the validity period and/or refuse to accept the award of a contract when and if awarded, then you will be excluded from the list of Suppliers for the project for three years.

Submission and Opening

- (f) Electronic bidding submission procedures shall be:
The RFQ documents will be uploaded in the E-Tendering portal (<https://assamtenders.gov.in>) and will be visible to all viewers. Intended bidders can login to the portal with their already registered ID's and can download the Bidding documents. They will then upload/submit the quotations with the signed and scanned copy of required documents mentioned in the bidding document in the in PDF format except the "PRICE SCHEDULE" (i.e. BOQ document), which is required to be filled by bidders in templates available in Excel format in addition to signed & scanned copy in pdf format.
- (g) Your **Form of Quotation** with the priced **Supply and Delivery Schedule** should be submitted by **08/07/2025 at 2.00 PM** with the required documents.

- (h) Electronic bid opening procedure shall be as follows:
Quotations Opening- Concerned/designated officials of ASUP will login to E-Tendering portal with their respective DSC's. Once all the designated officials complete their login procedure, then the Bid is considered to be opened. There after the submitted quotations would be downloaded for evaluation.
- (i) Quotations shall be opened electronically, in the presence of participating suppliers' representatives who choose to attend, on **08/07/2025 at 3:00 PM** and at the following address.

Evaluation and Comparison

- (j) Quotations determined to be substantially responsive to this **Request for Quotation** will be evaluated by comparison of their offer prices. A quotation is not substantially responsive if it contains material deviations or reservations to the terms, conditions, and specifications in this **Request for Quotation**.
- (k) In evaluating the quotations, the Purchaser will adjust for any arithmetical errors as follows:
- I. where there is a discrepancy between amounts in figures and in words, the amount in words will govern; and
 - II. where there is a discrepancy between the unit rate and the line-item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern.

If you refuse to accept the correction, your quotation will be rejected.

Award of Contract

- (l) The Purchaser shall award the contract to the Supplier whose quotation has been determined to be substantially responsive to this **Request for Quotation** and who has offered the lowest price quotation. Accordingly, award will be given to only one supplier.
- (m) The Supplier whose quotation has been accepted will be notified by the Purchaser within **42 days** (Forty-Two Days) from the date of submission of quotation through the return of a copy of the **Form of Quotation** with **Acceptance** signed by the authorized representative of the Purchaser.
- (n) The successful Supplier shall sign the **Contract** governed by the **Contract Terms and Conditions**.

The purchaser reserves the right to accept or reject any Bid, and to cancel the Bidding process and reject all bids, at any time prior to the awards of Contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligations to inform the affected Bidder or Bidders of the grounds for the purchaser's actions.
