Notification for 2nd Semester Back Examination, 2026

In pursuance of the resolution adopted in the Meeting of the Dean Academics, Heads of Departments, and Officials from the Office of the Controller of Examinations held on **06 August 2026**, and in accordance with the provisions of the **Assam Skill University Ordinance of Examination**, it is hereby notified for information of all concerned students that the **2nd Semester Back Examination, 2026** shall be conducted by the Office of the Controller of Examinations as per the schedule mentioned below.

This examination is intended to provide an opportunity to eligible students to clear their back papers and fulfil the academic progression requirements prescribed under the University regulations.

Eligibility: Students of the **2nd Semester** having back papers/failed courses and eligible to appear under the prevailing rules and regulations of Assam Skill University may apply for the examination.

A consolidated **Examination Fee of ₹1,000/- (Rupees One Thousand only)** shall be payable by each eligible student irrespective of the number of back papers/courses to be appeared in during this examination cycle.

Instructions to the concerned Students

1. Eligible students must submit the prescribed examination form (only for Back papers) along with the requisite fee within the stipulated period on 10th August, 2026.

3. Students are advised to verify the courses/papers for which they are eligible (having Back/ Not Clear), through the concerned HoD or the Exam Department, before submitting the examination form.
